**NJROTC Parents Club Nominating Committee Procedures
Election of 2010-2011 Executive Officers
Nominating Deadline: April 11th, 2010**

1. Beginning March 3rd, Nominations for the Executive Board positions should be submitted via email, to ALL members of the nominating committee.

2. The **deadline** to submit nominations to the committee is **Sunday, April 11, 2010**.
Nominations will not be accepted past this deadline.
3. You must state what position you want to run for, or if someone else is nominating another member, they must state the position and the person whom they are nominating. If 2 people want to run for one position they will be added to the ballot as a team (i.e. Mickey Kleinhans and Cathy Rinaldi - Co Presidents).

4. Only members of the NJROTC Parents Club can be nominated. The members must also be in good standing (have attended at least 2 Parents Club meetings). The nominating committee will verify the nominee's attendance.
5. If a member or team is nominated by another member, the Nominating Committee will verify that the member or team accepts the nomination.
6. At the April 14th NJROTC Parents Club meeting, the Nominating Committee will present the nominations for all positions.
7. During the April 14th meeting, all members in good standing will receive a ballot and will vote at the meeting. Please remember, you need to be present at the meeting in order to vote.
8. Nominating Committee will ask each nominee to give a brief introduction of whom they are and why they should be elected to the position.
9. The votes will be tallied and the winners will be announced at the end of the meeting.
10. The Executive Board Officers will assume their positions at the close of the school term and shall serve for a term of 1 year, and or, until the successors are installed.
 - (a) Exception: the Treasurer's position will transition at the end of August when the PTSO and NJROTC audits are complete.
11. Once elected, all Executive Board Officers must become members of the PTSO.
12. Any officer may be removed by the majority vote of the Executive Board whenever it is the judgment of the Executive Board that the best interest of the NJROTC Parents Club would be served by such action.
13. The vacancy shall be filled by the majority vote of the Executive Board for the unexpired portion of the term.
